LNAL CHARGES FOR USE, NON-USE AND DETENTION OF HEAVY CAPACITY OR SPECIAL TYPE FLAT CARS

1. Charges assessed under this item will accrue to Kasgro Rail Corporation and are assigned and payable to Kasgro Railcar Management, P.O. Box 423, East Liverpool, OH.,43920-0423. The use or additional detention charges will apply on LNAL cars when these cars are furnished for use in:
 - A. Line haul service for all carriers.
 - B. Switching service for all carriers.
3. Charges assessed under this item will be in addition to any other charges, including normal demurrage charges.
4. These charges will apply at or between all stations in the United States, and/or Canada and/or Mexico.
5. LNAL cars and their basis for charges. 12. When ST is origin carrier, any and all applicable use and detention charges accrued will be billed and collected by KRL; also, when ST is the delivering carrier, any and all destination detention accrued on the ST will be billed and collected by KRL.
13. When FEC is origin carrier, any and all applicable use and detention charges will be billed and collected by KRL. When FEC is the delivering carrier, any and all destination detention charges will be billed and collected by KRL.
