(b) - Change Note 2890 to read:

Applies to all LSRC stations making reference to this Note. Except as otherwise provided in tariffs or transportation contracts, any shipment loaded in a four axle car exceeding 263,000 lbs. per car gross weight on rail must be approved prior to movement over LSRC. Customer must arrange appropriate pricing for shipments exceeding 263,000 lbs. gross weight on rail. For approval contact LSRC at (989)-757-2127.

Shippers are responsible for obtaining proper clearance approval before loading cars of excessive heights to restricted territories that cannot handle cars of excessive heights. For height clearance contact LSRC at (989)-757-2127.

(c) - Change Note 2895 to read::

This station is not physically served by the LSRC, but by the HESR for the LSRC through a switching agreement and is shown for rating and billing purposes only. (LSRC)
